LDV04	Number of FTEs	In order to be able to determine the size of the business, the number of FTEs working for the business as a whole is registered at the Better Life Foundation trademark.	FTE stands for Full Time Equivalent, or the number of hours that a full-time employee works. The number of FTEs within a company indicates how many full-time jobs exist.  A business with ten part-time employees who all work half a week, for example, has five FTEs, while a business with six employees who work full-time has six FTEs.  Both the employees in permanent/temporary employment and externally hired workers are taken into account for the total number of FTEs.	Make a note of the number of FTEs (permanently employed, temporarily employed and externally hired) who work in the business as a whole on the basis of the personnel records.	AR
